Types of data collected

Among the Personal Data collected by this Website, independently or through third parties, there are: name; last name; email; Cookies; Usage data.

Full details on each type of data collected are provided in the dedicated sections of this privacy policy or through specific information texts displayed before the collection of the data.

Personal Data may be freely provided by you or, in the case of Usage Data, automatically collected during the use of this Website.

Unless otherwise specified, all Data required by this Website is required. If you refuse to disclose them, it may be impossible for this Website to provide the Service. In cases where this Website indicates certain Data as optional, Users are free to refrain from communicating such Data, without this having any effect on the availability of the Service or its operation.

Users, who may have doubts about which Data are mandatory, are encouraged to contact the Data Controller.

Any use of Cookies – or other tracking tools – by this Website or by third-party service owners used by this Website, unless otherwise specified, is intended to provide the Service requested by the User, in addition to the additional purposes described in this document and in the Cookie Policy, if available.

You assume responsibility for the Personal Data of third parties obtained, published or shared through this Website and guarantee that you have the right to communicate or disseminate them, freeing the Data Controller from any liability to third parties.

How and where the collected data are treated

How to treat

The Data Controller takes the appropriate security measures aimed at preventing unauthorized access, disclosure, modification or destruction of data Personal. Il processing is carried out through IT and/or telematic tools, with organizational methods and with logics closely related to the stated purposes. In addition to the Data Controller, in some cases, other parties involved in the organization of this Website (administrative, commercial, marketing, legal, system administrators) or external subjects (such as third-party technical service providers, postal couriers, hosting providers, IT companies, communication agencies) also appointed, if necessary, Data Controllers by the Data Controller, may have access to the Data. The updated list of Managers can always be requested from the Data Controller.

Legal basis for processing

The Data Controller treats personal data relating to you in case there is one of the following conditions:

- you have given your consent for one or more specific purposes. In some legal systems, the Data Controller may be authorized to process Personal Data without the user's consent or any other of the legal bases specified below, until the User objects ("opt-out") to such processing.

However, this is not applicable if the processing of Personal Data is regulated by European legislation on the protection of Personal Data;

- processing is necessary for the performance of a contract with you and/or for the execution of pre-contractual measures;
- the processing is necessary to fulfill a legal obligation to which the Data Controller is subject;
- the processing is necessary for the execution of a task in the public interest or for the exercise of public powers of which the Data Controller is invested;
- processing is necessary for the pursuit of the legitimate interest of the Data Controller or third parties.

However, it is always possible to request the Data Controller to clarify the concrete legal basis of each treatment and in particular to specify whether the processing is based on the law, provided for by a contract or necessary to conclude a contract.

Place

The Data are processed at the Data Controller's operational offices and in any other place where the parties involved in the processing are located. For more information, please contact the Data Controller. Your Personal Data may be transferred to a country other than the one where you are located. To obtain further information about the place of processing, you may refer to the section on details on the processing of Personal Data.

You have the right to obtain information about the legal basis of the transfer of Data outside the European Union or to an international organization under public international law or consisting of two or more countries, such as the UN, as well as about the security measures taken by the Data Controller to protect the Data.

The User can check if one of the transfers described above takes place by examining the section of this document relating to the details on the processing of Personal Data or ask the Data Controller for information by contacting him at the details reported at the opening. Retention period

The Data are processed and stored for the time required by the purposes for which they were collected.

therefore:

- Personal Data collected for purposes related to the performance of a contract between the Data Controller and the User will be withheld until the execution of such contract is completed;
- Personal Data collected for purposes attributable to the legitimate interest of the Data Controller will be withheld until this interest is satisfied. The User may obtain further information about the legitimate interest pursued by the Data Controller in the relevant sections of this document or by contacting the Data Controller.

When the processing is based on your consent, the Data Controller may retain Personal Data for longer until such consent is revoked. In addition, the Data Controller may be obliged to retain Personal Data for a longer period in compliance with a legal obligation or by order of an authority. At the end of the retention period, Personal Data will be deleted. Therefore, at the end of this period, the right of access, deletion, rectification and the right to portability of data can no longer be exercised.

Purpose of the Processing of collected Data

Your Data is collected to allow the Data Controller to provide the Service, fulfill legal obligations, respond to requests or enforcement actions, protect its rights and interests (or those of Users or third parties), detect any malicious or fraudulent activities, as well as for the following purposes:

Data for any other purpose than their storage.obtain the deletion or removal of their Personal Data. When certain conditions are met, the User may request the cancellation of his Data by the Data Controller;

- receive their Data or have them transferred to another data controller. You have the right to receive your Data in structured format, common use and readable by automatic device and, where technically feasible, to obtain its transfer without obstacles to another owner. This provision is applicable when the Data are processed with automated tools and the processing is based on your consent, a contract to which you are a party or contractual measures related to it;
- lodge a complaint. You may lodge a complaint with the competent personal data protection supervisory authority or take legal action.

Details of the right of objection

When Personal Data are processed in the public interest, in the exercise of public authority of which the Data Controller is invested or to pursue a legitimate interest of the Data Controller, Users are entitled to object to the processing for reasons related to their particular situation.

Please note to users that, if their Data are processed for direct marketing purposes, they may object to the processing without providing any reason. To find out if the Data Controller treats data for direct marketing purposes, Users can refer to the respective sections of this document.

How to exercise rights

To exercise your rights, Users may address a request to the Contact Details of the Data Controller indicated in this document. Requests are filed free of charge and processed by the Data Controller as soon as possible, in any case within one month.

Personal Data (or Data)

Any information which, directly or indirectly, also in connection with any other information, including a personal identification number, makes a natural person identified or identifiable, shall be personal data.

Usage data
